MONTGOMERY COUNTY BOARD OF EDUCATION POLICY COMMITTEE

April 14, 2004

POLICY CNA – Informational Materials and Announcements

There was a discussion about closing the forum to certain organizations, especially sports, non-profits, and volunteer activities. It was pointed out that school principals have the authority to approve materials from local school, parent and student organizations. Legal counsel will review the policy, and it is scheduled for discussion and final action by the Board on April 26, 2004. [It was subsequently postponed at the request of the superintendent, pending the decision of the Fourth Circuit.]

Alignment of Policies and Strategic Plan

Staff presented a paper on core values policies, and those supporting the goals of the school system. The next steps are to identify the core governance policies, look at what drives a work plan, and develop a comprehensive plan to monitor and evaluate policies. The document will be placed on the next agenda for Board discussion (April 26, 2004).

POLICY IKA – Grading and Reporting

Staff reported that they are meeting with various groups. Staff handed out materials on the timeline, learning skills (Grades 1 - 5), learning skills rubrics, and guidelines for late work. High school principals are concerned about loss of credit, attendance, athletic eligibility, and teacher training.

The Policy Committee thought there was a strong relationship between the academic grade and the separate reporting of effort. It was suggested that there be added phases to the roll out of the policy since there were complex issues as well as the capacity to fully implement the policy.

A plan will developed for review by the Policy Committee at its next meeting. The implementation of the policy is scheduled for discussion at the May 11, 2004, Board meeting.

POLICY IJA – Student Counseling Programs and Services

The suggestions from the last meeting had been incorporated into the policy. The Policy Committee agreed that it was ready to the sent to the Board for tentative approvalonJune 21,

2004. [This has subsequently been postponed until July 6, 2004.]

POLICY AEB – Long Range Planning

The Long-Range and Strategic Planning Committee reviewed and edited the policy. There were some editorial changes suggested by the Policy Committee, and a clean document will be scheduled for review at the next meeting. The policy is scheduled for tentative approval by the full Board on June 21, 2004.
