THE VIEW FROM THE TOP OF A CLIFF

What is it that draws people to want to view life from high places? Many of us have been fortunate enough to do some traveling and sightseeing over the years, especially now that we are retired. The best place to see the splendor of Paris is from atop the Eiffel Tower. How many of you have gazed down at the magnificence of the Grand Canyon from its rim? Or stood on Goat Island at the top of Niagara Falls, mesmerized by the power of the water going over the precipice? Have any of you been awed by the beauty of the volcanic crater of Haleakala on Maui from the view at the top? Even our capital city of Washington, DC, looks incredibly gorgeous from atop the Washington Monument. You, however, cannot fail to notice the warnings posted at each of these and many other sights regarding the dangers of getting too close to the edge. Our subconscious fear from many a nightmare of falling off a cliff make us carefully heed those warnings. We never want to get so close to the side that our own weight causes the rock to crumble under our feet and send us over the side.

Think, however, what it would be like if, by no fault of your own, you ended up at the bottom of a cliff because you were pushed or you tripped. If you, by some stroke of luck, managed to survive the fall, what would you do next? You most likely would analyze the extent of your injuries first and then survey your surroundings to locate anything that might aid in your survival. It is very doubtful that your fall went unnoticed by those above so you just have to pray that they have arranged for a rescue crew to come help you. After much effort and assistance, you feel very grateful to have been lifted back up the cliff and to have lived through the experience.

We all like stories with happy endings. Not all of life's experiences, however, can be rewritten so that "all is well that ends well." Let's think about another cliff that has been in the news constantly since November or so of last year, the dreaded Fiscal Cliff. We all stood prisoners at the edge of this precipice hoping that those who had the power to prevent a disaster would come to a consensus on a plan to rescue us rather than push us over that cliff. Was there much we could, as individuals, do to keep from taking the plunge? Fortunately, no one tripped or pushed us over. Well, not all of our county's residents have been as luck as most of us. They, unfortunately, went over the fiscal cliff a long time ago and are now trying desperately to survive. They lack jobs, adequate housing, food and clothing for their families, the bare necessities of life. The view from the bottom of the cliff must be terrifying. But where are their rescue teams? Surely, their fall into poverty did not go unnoticed. Do we need special training to help pull them back up the cliff? Of course not! So why isn't more being done to lift them up?

There are countless ways to be part of a life-saving team. Donate items of food and clothing to a local food pantry or shelter. "Adopt" a needy child at one of our many county schools and see what you can do to assist his or her family. Call the county government and see what opportunities are out there for you to donate your time, talents, and money to assist others in need. And PLEASE consider making a tax-deductible contribution to our association's own Toolkits, Books, and Backpacks Project. This project has helped literally thousands of needy children in our county over the last nine years by providing much needed school supplies, books, and backpacks for the children to have at home to assist their learning at school. Many hands make light work of what may seem like a daunting task. Be part of a rescue team! Help children and their families to climb back up that fiscal cliff and see once again the view of the world from the top of the cliff. Thanks for being part of the team!

PLEASE TAKE TIME TO READ THIS IMPORTANT INFORMATION. SHARE IT, ALONG WITH SPECIFIC TRIP INFORMATION, WITH YOUR GUESTS.
