Mrs. Praisner asked for information on when they would be reviewing the question of relocatables at Gaithersburg High School. She commented that she liked the name "Strawberry Knolls" for the new elementary school, but they had a process to go through for naming schools. She would like this done as soon as possible so that they would not be faced with administrative problems of getting the school name on library books. She asked that the Board review the issue of the location and size of the area office proposed for Area 3. Mr. Ewing requested information about designated classrooms for art and music, where they had been unable to do this, for how long, and how many situations would they have next fall and in the fall of 1988. He did not limit his question to the up-county. He requested information on what remained to be done in the remodeling of the Gaithersburg High School kitchen and when it would be finished. Mr. Ewing asked for information on space for materials in the media center at Gaithersburg High School provided that they had the funds to add the needed materials.
