Re: ELEMENTARY INTEGRATED CURRICULUM FRAMEWORK

Dr. Weast invited the following people to the table: Mr. Erick J. Lang, associate superintendent, Office of Curriculum and Instructional Programs; Mr. Martin M. Creel, director, Department of Enriched and Innovative Programs; Ms. Theresa A. Cepaitis, director, Elementary Integrated Curriculum Team; Mrs. Niki T. Hazel, supervisor, Elementary Integrated Curriculum Team; Ms. Laura Evans, supervisor, Elementary Integrated Curriculum Team; Ms. Laura Evans, supervisor, Elementary Integrated Curriculum Team; A. Raymond Myrtle, supervisor, Elementary Integrated Curriculum Team.

This item was presented to the Board for preliminary approval of the Montgomery County Public Schools (MCPS) Elementary Integrated Curriculum Framework. Curriculum frameworks are submitted to the Board of Education as required by Board of Education Policy IFA, Curriculum, and in support of Goal 1 and Goal 2 of Our Call to Action: Pursuit of *Excellence*, the MCPS strategic plan. The framework establishes the organization and sequence of what students should know and be able to do at the end of each subject, grade level, or course. The standards and objectives included in this framework are from content frameworks previously approved by the Board of Education in all areas, except for information literacy, thinking and academic success skills, reading/language arts, and mathematics. The standards and objectives for reading/language arts and mathematics in this framework are based on the Common Core State Standards (CCSS). The Maryland State Board of Education adopted the CCSS in English/language arts and mathematics on June 22, 2010. All curriculum and assessments in Maryland within these two critical areas will be based on the CCSS. The Office of Curriculum and Instructional Programs will submit a recommended secondary framework in English and mathematics based on the CCSS for approval later this school year. The Thinking and Academic Success Skills were developed by MCPS as part of the Elementary Integrated Curriculum and are submitted pending further collection of feedback and approval at a later Board meeting. This framework includes new information literacy standards developed by the Maryland State Department of Education.

Re: **DISCUSSION**

Ms. Berthiaume noted that the rollout of the kindergarten and first grade curricula is in place, but there are no assessments. Mr. Kauffman remarked about the assessments in the past for reading levels for kindergarteners; how did the pilot schools perform on standardized reading assessments? Staff replied that the data will be gathered to assess the improvements, and there was a small study using the MCPS AP-PR (hand-held assessment) for reading levels. Ms. Berthiaume asked that the data be made available to the Board.

Mrs. O'Neill wanted to know more about differentiation, especially for highly able students. Staff explained that the integrated curriculum shows the teacher that there is not a lockstep approach to instruction, and students need to be held to a set of standards. How that happens is through collaborative team planning and differentiated resources. Finally, professional development needs to be specific to what teachers need for differentiation. Mrs. O'Neill noted that the common core standards are mandatory from the state. Will the assessments be state-generated? Staff stated that the assessments from the state may change the MSA and/or HSA tests.

Mrs. O'Neill asked about group projects. Staff replied that there will be collaborative projects with individual scoring.

Mr. Barclay wanted to know who is using the web-based tool, and how are they trained. Staff replied that school staff is using the site, and there is the ability to gather data on users. Furthermore, the site is constructed to be "point and click" for ease of use.

Mr. Barclay noted that in success/skill indicators there is metacognition, which is an area to develop in young people. Staff explained that metacognition is reflecting on how an individual learns.

Ms. Berthiaume remarked that differentiation is a good therapy, but a teacher with a classroom of students has to deal with strategies to keep all students learning and progressing at different levels. She asked about a group of students that is moving slowly and taking two weeks to accomplished one week of instruction. Staff replied that professional development provides the teacher with the skills to differentiate for all students. Furthermore, the site has hyperlinks to resources, which makes it easy for teachers to retrieve material and observe teaching techniques. Also, when a group is moving slowly, teachers are expected to use formative assessments and use the data for planning to meet the needs of the students.

Ms. Berthiaume noted the planned day on the website, and she asked if there was autonomy for the individual classroom teacher. Staff explained that the material on the site illustrates an integrated model, but it is not required. Furthermore, the model is accompanied with content and resources.

Mr. Barclay wanted to know how to address the issue of creativity in teaching with rigid assessments. The resources available to teachers using technology are a "click" away. Technology is working in our favor, but is there data demonstrating that instruction is better? He wanted to know if it improves instruction and if there are gaps. When the budget comes before the Board, the Board needs to know that this is money well spent. Finally, professional development is an expensive piece of instruction. Staff replied that this project is funded with a federal grant. The Seven Keys lead a student to college, and this will be used to square the instructional focus. There are more resources available instantly. Finally, the key is a quality teacher aided by staff development teachers in the evolution of a learning community within MCPS.

Dr. Docca agreed with the focus of getting teachers to work together rather than in isolation. The materials are extremely rich and helpful for the teachers. Finally, it is important to check for student understanding of the material at small intervals. Mrs. O'Neill was concerned about the assessments for the common core standards. It is suggested that

there are three assessments prior to a final assessment. Staff explained that there are a lot of measurements to inform instruction, and they were concerned about high stakes testing on a statewide basis. The state has sent people to look at the curriculum and, hopefully, there will be alignment with the assessments.

Ms. Berthiaume asked about gifted instruction and building a curriculum framework for the top 5 percent. Would it look different? Staff stated that the standards are the Maryland standards, but there is exceptional depth in how it plays out.

Ms. Brandman inquired about integrated curriculum and how other subjects are brought into the instruction. Staff replied that integration is through the critical thinking academic success skills. Unifying questions focus integration or the thread that permeates each of the content areas. Staff tries to provide a sequence that maximizes the natural connections among content.

Ms. Brandman referred to standards-based instruction and the new report card. How does the framework fit into standards-based instruction? Staff replied that the framework has a page with an overview of the desired outcomes that students should know and be able to do by the end of the grade level. It is for those items that are measured and related to the standards.

Ms. Berthiaume commented that it is essential in the 21st century for students to know social studies and geographic knowledge.

WHEREAS, The Montgomery County Board of Education approved the curriculum frameworks in English/language arts, mathematics, science, and social studies on July 2, 2001, and approved frameworks in visual arts, general music, health education, and physical education on April 20, 2006; and

WHEREAS, The Maryland State Board of Education adopted the Common Core State Standards in English/language arts and mathematics on June 22, 2010; and

WHEREAS, Montgomery County Public Schools has created the research-based Thinking and Academic Success Skills Framework; and

WHEREAS, Montgomery County Public Schools has woven the Thinking and Academic

Success Skills into the existing curriculum frameworks along with the Common Core State Standards to form the innovative Elementary Integrated Curriculum; and

WHEREAS, Feedback and input from stakeholders will be used to develop and refine the Elementary Integrated Curriculum and Thinking and Academic Success Skills framework; now therefore be it

<u>Resolved</u>, That the Montgomery County Board of Education grant preliminary approval of the MCPS Elementary Integrated Curriculum Framework, which combines existing elementary curriculum, Common Core State Standards, and Thinking and Academic Success Skills as the foundation for the development of the Elementary Integrated Curriculum.
