Question 1: What would be your top three realistic priorities as the Student Member of the Board of Education?

If elected SMOB there are many things I would like to improve in our county. Communication between students and the SMOB hasn't always been effective. I would continue the Student Advisory Committee as a means of communication between students from every school and the SMOB, and expand communication efforts using internet blogs, television shows, and more student comment time at Board meetings. The achievement gap is also a growing problem in this county. Another goal of mine will be to address policies, like the eligibility and LC policies, that contribute to this gap. Finally, I want to address health issues that exist in our schools. We can improve our cafeterias through elevated health standards and improve our bathrooms by ensuring they are clean and well-stocked.

Question 2: Stress and violence continues to grow countywide. Should schools be required to have classes in conflict resolution, peer mediation, and positive mental health to help students deal with these problems? What other recommendations do you have to help students feel safe in school?

Though I don't think our county needs to mandate a conflict resolution class, I'm concerned with the recent rise in violence in our schools and would like to look into ways of making students feel safer. I would support a mandated workshop or assembly devoted to conflict resolution, peer mediation, and understanding diversity. The best way to make students feel safe around each other is to work to understand one another.
