Mr. Durso commented on the cluster meetings (Blair and Wheaton) and commended those who arranged and attended the meetings. The students were great ambassadors from their schools.

Dr. Docca stated that she attended the Montgomery County Alliance of Black Educators Showcase which had fantastic performances and raised money for scholarships and professional training.

RESOLUTION NO. 85-12 Re: **FY 2012 SUPPLEMENTAL APPROPRIATION
REQUEST FOR RELOCATABLE
CLASSROOMS**

On recommendation of the superintendent and on motion of Mrs. O'Neill seconded by Mr. Barclay, the following resolution was adopted unanimously:

WHEREAS, The Board of Education's Requested Fiscal Year 2013–2018 Capital Improvements Program includes \$4.0 million in the Fiscal Year 2013 Capital Budget for relocatable classrooms to accommodate student population changes for the 2012–2013 school year; and

WHEREAS, These funds are programmed to be expended during summer 2012 but will not be available until the County Council takes final action on the Board of Education's Capital Improvements Program request in May 2012; and

WHEREAS, The contracts for the leasing, relocation, and installation work for the Fiscal Year 2013 relocatable classroom moves must be executed prior to May 1, 2012, in order to have the units ready for the start of school in August 2012; and

WHEREAS, The appropriation authority to expend the funds programmed for Fiscal Year 2013 must be approved by the County Council before the Board of Education can enter into contracts; now therefore be it

Resolved, That the Board of Education requests a Fiscal Year 2012 supplemental appropriation in the amount of \$4.0 million to accelerate the requested Fiscal Year 2013 appropriation to provide for the execution of contracts for leasing and relocatable classroom moves planned for summer 2012 to address school enrollment changes in time for the beginning of the 2012–2013 school year; and be it further

Resolved, That this request be forwarded to the county executive and the County Council for action.

RESOLUTION NO. 86-12 Re: **UTILIZATION OF THE FY 2012 PROVISION
FOR FUTURE SUPPORTED PROJECTS**

RESOLUTION NO. 87-12

Re: **FY 2013 SUMMER SCHOOL FEES**

On recommendation of the superintendent and on motion of Mrs. O'Neill seconded by Mr. Barclay, the following resolution was adopted unanimously:

WHEREAS, The Board of Education approves tuition fees each year for summer school; and

WHEREAS, Summer School Revenue-based Program costs are projected to rise only slightly; now therefore be it

Resolved, That the Summer School Revenue-based Program full fees be maintained at the Fiscal Year 2012 rate (\$335 for elementary school courses; \$300 for high school courses; and \$310 for student online courses); and be it further

Resolved, That the Summer School Revenue-based Program reduced fees be maintained at the Fiscal Year 2012 rate (\$85 and \$120, respectively, depending upon family income); and be it further

Resolved, That the total annual family income guidelines for qualifying for reduced fees and waivers be maintained at \$0–\$29,812 for the lowest reduced fee; \$29,813–\$42,425 for the higher reduced fee; and below \$42,425 for waivers; and be it further

RESOLUTION NO. 92-12 Re: **PREVIOUS NEW BUSINESS: POLICY CNA, INFORMATIONAL MATERIAL AND ANNOUNCEMENTS**

On motion of Mr. Kauffman and seconded by Mrs. O'Neill, the following resolution was adopted with Mr. Barclay, Ms. Brandman, Dr. Docca, Mr. Durso, Mr. Kauffman, Mrs. O'Neill, and Mr. Xie voting in the affirmative; Ms. Berthiaume voting in the negative:

WHEREAS, On July 29, 2004, the Board of Education adopted Policy CNA, *Informational Material and Announcements*; and

WHEREAS, On August 10, 2006, the United States Court of Appeals for the Fourth Circuit declared Board of Education Policy CNA, *Informational Material and Announcements*, unconstitutional in certain respects. Consequently, the implementation of the policy was suspended, pending action by the Board of Education to revise the former policy; and

WHEREAS, On August 30, 2006, the Board of Education revised Policy CNA, *Informational Material and Announcements*, and authorized the superintendent to develop reasonable viewpoint-neutral regulations to implement this policy; and

WHEREAS, Pursuant to Policy CNA, *Informational Material and Announcements*, and Regulation CNA-RA, *Display and Distribution of Informational Materials and Announcements*, staff members at each school designate one (1) day within the first 15 days of the school year for the distribution of printed informational materials and announcements from nonprofit community organizations, as well as designate three additional days (one each after the end of the first, second, and third marking periods) for the distribution of printed informational materials and announcements from nonprofit community organizations; and

WHEREAS, In February 2012, schools distributed to students flyers from a community organization that prompted expressions of great concern from parents, staff, and students; now therefore be it

Resolved, That the Board of Education direct the Policy Committee to review Policy CNA, *Informational Material and Announcements*, in light of the concerns raised by the community and to make a recommendation to the Board regarding any appropriate changes to the policy.

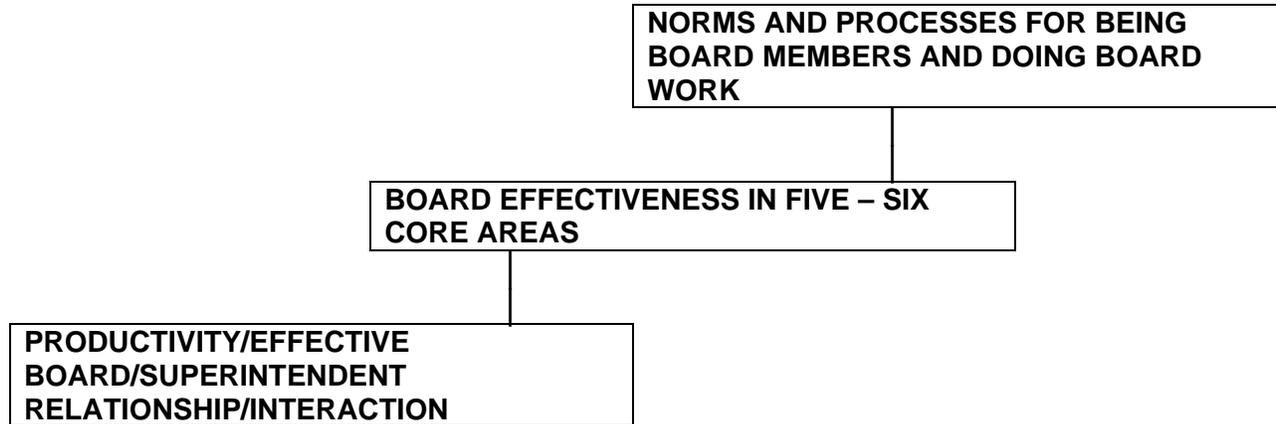

RESOLUTION NO. 93-12

Re: **RECOMMENDED POSITION ON EDUCATION LEGISLATION**

On recommendation of the superintendent and on motion of Mrs. O’Neill seconded by Mr. Kauffman, the following resolution was adopted unanimously by members present:

Resolved, That the Board of Education strongly opposes ***HB1049 - Elementary and Secondary Education – County - Supervised Home Instruction – High School Diploma*** which would authorize a certain individual who received home instruction under the supervision of a county board of education to apply to a certain county board to obtain a high school diploma under certain circumstances; requiring a certain county board to award a high school diploma to certain individuals; requiring a certain county board to adopt certain rules and regulations; and generally relating to obtaining a high school diploma for the completion of county-supervised home instruction for elementary and secondary education.

RESOLUTION NO. 94-12

Re: **RECOMMENDED POSITION ON
EDUCATION LEGISLATION**

On recommendation of the superintendent and on motion of Mrs. O'Neill seconded by Mr. Kauffman, the following resolution was adopted unanimously by members present:

Resolved, That the Board of Education strongly opposes **HB0980 – County Boards of Education - Children in Home Instruction Programs** which would alter the definition of “full-time equivalent enrollment” to include certain children participating in a home instruction program; requiring a county board of education to count certain children participating in a certain home instruction program in the county’s full-time equivalent enrollment if the parent or guardian of the child agrees to require the child to participate in a certain testing program; requiring a county board to remit a certain amount of money to the parent or guardian of a child receiving home instruction under certain circumstances; requiring a certain parent or guardian to use certain money to purchase educational materials for a certain purpose; and generally relating to counting children in home instruction programs in full-time equivalent enrollment counts.

RESOLUTION NO. 95-12

EDUCATION LEGISLATION**

On recommendation of the superintendent and on motion of Mrs. O'Neill seconded by Mr. Kauffman, the following resolution was adopted unanimously by members present:

Resolved, That the Board of Education opposes **HB1210/SB0876 - Public School Teachers and Administrators - Appeals and Layoffs - Rights and Limitations** which would limit the review by the State Board of Education of the decision of a county board to suspend or dismiss certain public school teachers and administrators to a review on the record; requiring public school employers to negotiate teacher layoff policies as part of collective bargaining; requiring the use of performance evaluations in policies relating to layoffs of public school teachers; providing for the effective date of certain provisions of this Act; providing for the termination of certain provisions of this Act; and generally relating to the rights and limitations of rights of certain public school teachers and administrators regarding appeals and layoffs.

Resolved, That the Board of Education has no position on **SB0948/HB1177 - Ethics - Financial Disclosure by Local Elected Officials and County Boards of Education**

which would authorize a county, municipal corporation, or school board to limit in a certain manner the required disclosure of interests in certain business entities by local elected officials, members of school boards, and candidates for election or appointment to those offices; and generally relating to financial disclosure requirements for counties, municipal corporations, and school boards under the Maryland Public Ethics Law.

RESOLUTION NO. 97-12 Re: **RECOMMENDED POSITION ON
EDUCATION LEGISLATION**

Resolved, That the Board of Education opposes ***SB0878 - Education - Preschool for All - Establishment and Funding*** which would establish certain funding for prekindergarten students by altering a certain definition to include prekindergarten students in the number of students enrolled; altering a certain funding calculation to phase in a reduction of certain funding; altering a certain definition to make certain children eligible for prekindergarten; requiring certain prekindergarten programs to be established by a certain school year; authorizing county boards to use qualified vendors to provide prekindergarten programs; requiring the State Department of Education to establish provider rates for qualified vendors; requiring the Department to provide a certain list to each local school system; requiring the Department to evaluate qualified vendors using certain criteria at least every years; authorizing the Department to evaluate qualified vendors more frequently and to revoke certification under certain circumstances; requiring the Department to adopt certain regulations; requiring the Department to develop a certain media campaign; authorizing the Department to adopt regulations; naming the Preschool for All program; requiring each prekindergarten program under the jurisdiction of a county board to be open during a certain number of hours over a certain number of months for certain students; authorizing certain funds to be used to provide funding for universal prekindergarten; defining certain terms; authorizing the State to allow certain licensees to offer certain table games; requiring the Comptroller to make certain distributions from certain proceeds; prohibiting certain licensees from being charged a certain fee; authorizing the State Lottery Commission to make certain determinations; making this Act subject to a certain contingency; authorizing certain funds to be used to provide funding for certain purposes; establishing a certain funding calculation for a certain year; providing for the application of this Act; submitting this Act to a referendum of the qualified voters of the State; and generally relating to education funding and access for prekindergarten.

Resolved, That the Board of Education opposes **HB0831 - Education - Public Schools - Parent Trigger** which would authorizing certain parents and legal guardians of students attending public schools that are subject to corrective action and are not making adequate yearly progress to petition county boards of education to implement certain interventions; requiring county boards to notify the State Superintendent of Schools and the State Board of Education on receipt of certain petitions and of the final dispositions regarding the petitions; requiring county boards to make certain determinations in a certain manner within a certain time frame; requiring county boards to designate interventions other than the options requested by certain petitions under certain circumstances; requiring county boards to notify the State Superintendent and the State Board that certain interventions have substantial promise of enabling certain schools to make adequate yearly progress; requiring certain students to have the option of receiving a certain scholarship in a certain amount for a certain time period; requiring certain funds to be calculated in a certain manner; requiring certain counties to include certain students in their full-time equivalent enrollment; requiring the State Board to adopt certain regulations; prohibiting the expansion of certain regulatory authority regarding certain private schools; defining certain terms; and generally relating to authorizing parents of students attending public schools that are subject to corrective action to petition county boards of education for an intervention.

Resolved, That the Board of Education supports ***SB0605/HB757 - Education - Children in State-Supervised Care - Geographical Attendance Area*** which would authorize a child to remain in a school in a certain geographical attendance area regardless of whether the child resides within the area under certain circumstances; requiring that certain determinations regarding the best interests be made; requiring a county superintendent to allow a child to remain at a school the child attended prior to the child's removal from the child's home; requiring the Secretary of Human Resources to adopt certain regulations establishing certain factors relating to the best interests; prohibiting requiring a person enrolling a child in the school to produce certain documentation; requiring a certain child placement agency that has been unable to produce certain records to assist a certain school in obtaining the records under certain circumstances; requiring a certain child to remain enrolled in a certain school during a period of time when records are obtained; defining a certain term; and generally relating to authorizing a child in State-supervised care to remain in a school regardless of whether the child resides in the geographical area of the school.
