## MONTGOMERY COUNTY BOARD OF EDUCATION Rockville, Maryland

The Montgomery County Board of Education held a business meeting on February 22, 2024. At the time, the Board took the following positions on the proposed legislation contained herein.

## BILLS ON WHICH THE BOARD TOOK A POSITION

HB 137 – Civil Actions – Civil Immunity – Educator Intervention

Board Position: Support

Rationale:

The Board supports the legislation's attempt to provide further legal protections to our staff members who intervene in alterations in an attempt to keep students and staff safe. Although current law provides indemnification from damages potentially awarded in lawsuits stemming from injuries obtained during altercations, this bill would provide legal immunity from suit. This would result in the staff member not having to engage in the legal process at all, rather than just being protected from any outcome of the litigation.

HB 791/SB 552 - Operating Budget - Funding - Scholarships for Nonpublic School Students

Board position: **Oppose** 

Rationale:

The Board opposes the use of public funds for private education, which would be the result if this bill passes. If enacted, the Board is at risk of losing \$18,279 per student in combined state and local revenue (FY24) for every Free and Reduced-Price Meals (FARMs) eligible student in MCPS who chooses to attend a non-public school and receives this scholarship.

HB 1084/SB 1061 - Employee Autoimmune Disorder Protection Act

Board Position: **Oppose** 

Rationale: This bill would cause major operational impacts on MCPS's ability to

provide instruction to students and central office support to schools. Employees who have medical conditions that impact their ability to perform the essential functions of their positions can request accommodations under

the Americans with Disabilities Act.

<u>HB 1432/SB 1062</u> - Education - Prekindergarten and Withholding of County Board Funding (Blueprint Accountability and Flexibility Act of 2024)

Board Position: Oppose

Rationale: Although this bill may provide some benefits with regard to Blueprint

deadlines, it would create a system whereby the state could withhold county board funds if an LEA has low MCAP scores and/or negative OIG audit findings regarding use of funds. Any loss or reduction of state funding would negatively impact an LEA's ability to implement the Blueprint with fidelity,

harming students and staff.

<u>HB 1426/SB 1102</u> - Education - Blueprint for Maryland's Future – Alterations

Board Position: Support

Rationale: This bill could pose a financial burden for MCPS; however, the Board

prioritizes extending the benefits of earning National Board Certification to school-based staff other than just teachers-of-record and, as a result, incentivizing the career ladder and a career in education. Given this

position, the benefits of this bill outweigh the anticipated cost.

HB 522/SB 492 - Public Schools - Student Telehealth Appointments - Policy and Access

Board Position: Support with Amendment

Rationale: The Board supports the goal of the bill – making telehealth more available

to students throughout the school day. However, there are a couple issues that need to be addressed with amendments. Specifically, the Board is concerned about: 1. the absence of funding which would preclude equitable expansion of telehealth services to all schools and students, 2. safety concerns as adequate staffing may not be available and the bill's requirement that schools provide safe supervision is not well defined, and 3. implementation challenges related to parental support and consent issues related to the health care of minors. As a result, the Board requests that the

sponsor consider amending the bill to:

1. Eliminate the requirement for a dedicated telehealth space in middle and high schools unless financial support is provided for

schools unable to accommodate with current space and staffing resources;

- 2. Require state agencies (MSDE and MHD) to provide technical guidance on safe supervision standards during private telehealth visits and potential liability concerns; HIPAA/FERPA considerations as school personnel may have access to protected health information or be required to document such in non-HIPAA compliant educational record systems when coordinating appointments; and, school personnel's role, if any, in confirming or obtaining consent for care, and obligation to provide information to caregivers about students' telehealth appointments or care, for both general health services and confidential care protected by minor consent law; and,
- 3. Provide standard requirements for providers wishing to offer school-based telehealth services that incentivize equitable access for all students. Facilitating access for providers who do not accept health insurance or participate in Medicaid, and have no mechanism to offer services equitably to the entire student population, may increase existing health disparities.

HB 760 - County Boards of Education - Annual Financial Audits – Alterations

Board position: Support with Amendment

Rationale:

This legislation requires LEAs to address repeat audit findings with a public report detailing actions the LEA has taken to address the findings. The amendment, already agreed to by the sponsor, provides clarity regarding the type of report needed, the timing of issuing the report, and permits LEAs to keep certain information, that could present a security risk, confidential.

HB 988 - Montgomery County Board of Education - Vacancy Procedures - Alterations MC 5-24

Board Position: **Support** 

Rationale:

Bill will change the way Board vacancies are filled, in certain situations. This change brings the Board's procedure in line with County Council and the County Executive, as well as some of our larger jurisdictions, including Germantown, Gaithersburg, and Rockville.

HB 206 – Parent and Guardian Notice and Required Counseling

Board Position: **Oppose** 

Rationale:

The Board opposes this bill as it could have a negative impact on the relationship between the school administration and families and the bill does not contain clear direction about when the counseling would be

necessary, nor how families without financial means to afford counseling could comply with the requirements of the bill.

HB 704 - Primary and Secondary Education – Education Savings Account Program – Established

Board Position: **Oppose** 

Rationale: The Board opposes using public funds for private school. This bill would

have a negative fiscal impact on MCPS.
