Re: DMICS Staff Comment on the DMICS MORE Study

Mr. Stephen Raucher, director of the Department of Management Information and Computer Services, explained that the staff reaction and the MORE study would be sent to Mr. Richard Fazakerley, associate superintendent for supportive services, who would be heading the study group. The task force would be established in February with the final report coming to the Board in late summer. He said that they would have a clear plan for the next ten years in time for the formation of the FY 1983 budget. He indicated that the superintendent had requested three levels of planning from having all resources to having a minimal level of resources. Mrs. Wallace asked whether it would be the superintendent's task force. If so, she hoped that he would keep it small and seek the best minds out in the community.

Mr. Raucher replied that the recommendation was to have an internal committee, but they might want reviewers of their plan from the general community. Mr. Raucher called attention to the summary on the six major problem areas. The first was single year budgeting, and he felt that the task force would move to establish long-range planning.

The second was the technology, and the staff disagreed that they had failed to recognize the full impact of technology. He said that they did but could not afford to capitalize on the technology; however, the task force would be looking at this. The third problem was user departments had satisfied their data needs without regard to the need to interface with other data. Mr. Raucher said they agreed and felt that a long-range plan was needed for the school system. He said that someone had to have the overview responsibility because without a unified look they would not know the full costs. The fourth problem

was that they did not budget on a multiyear basis which he felt was related to the first three problems. The fifth problem was the current resources were below standard. The sixth problem had to do with staffing. He believed that they would address the problem of morale. In fact, morale had already improved because the school system and the Board of Education were listening to the department.

He said that the task force would have to take a look at these problems. Mr. Raucher stated that the next part of the paper was a reaction to the items in the executive summary. If they had no question on an item, it was omitted. In most of the cases there were minor points on which they did disagree. The second item dealt with mission assignment which got back to the question of overall administrative authority. He said they were looking at a technical resource activity. He said they did not have a chargeback system, and the contractor felt they should be looking at payback over a period of two to three years. He indicated that he would be pleased to respond to questions.

The superintendent reported that they were trying to do some coordinated long-range planning. They now had the consultant's report and the staff reaction and would have a task force with probably a review committee before the budget next year. He asked whether this was a reasonable timeline. Mr. Ewing felt that it was a good process and that the paper before the Board was a good one which helped him greatly.

Dr. Greenblatt asked when they would be asked to make policy decisions, and the superintendent replied that it would be probably mid to late summer. Dr. Greenblatt asked whether the policy issues would contain options, and Mr. Raucher replied that they would with costs and benefits of these options. Mr. Ewing pointed out that on page 3 of the staff response there was a diagram which showed the Board's involvement in inquiring for and receiving information. He hoped that the task force would bring to the Board not only issues on how much they were going to spend but what it believed were the Board's needs to know and in what time frame. He said that perhaps the task force could interview Board members about their own views and have a discussion with the Board on their informational needs. It seemed to him they needed to know what it was that they were asking for and what it would cost. He hoped that the task force would distinguish between the things meeting routine administrative responsibilities and those that were necessary and those that were optional but not essential.
