Dr. Greenblatt noted that there were 27 students in the sixth grade at Arcola. She asked whether there would be room in Lee Junior High School and in Kennedy High School if they were to switch the high school boundaries. Mrs. Spencer asked that they look at what would happen if all of Kemp Mill articulated there.

Dr. Greenblatt asked that staff look at the potential impact on Northwood/Einstein. Mrs. Wallace called attention to a portion of what was now the Glen Haven service area north of University Boulevard which they would normally think would be part of Arcola Elementary. She requested the student yield from that area. She said that Glen Haven through 1985-86 was at the 77 percent utilization rate, and she asked what would be the impact if all students north of University were considered part of Arcola and what would be the impact on Kemp Mill. She said that she had the same question on Oakland Terrace if the service area for Pleasant View ended at University Boulevard.
