First Semester Off-Campus Lunch Request

The student identified below has requested permission to leave the Damascus High School campus during the lunch period from 11:10 am – 12:00 pm for the first semester of the 2018-2019 school year. Requests for this privilege will only be considered if the parent/guardian provides permission by signing this form.

Seniors must meet the following criteria to be eligible for the off-campus lunch privilege:

- Student must be academically eligible based on 4th quarter grades from the previous school year.
- Student must have completed at least 60 hours of student service learning (SSL).

Note: Second semester requests will require 75 SSL hours

- Student has no financial obligations.

Students who are granted permission to leave campus during lunch must comply with school regulations and the following rules. Failure to abide may result in the temporary or permanent loss of off-campus lunch privileges.

- Students will demonstrate safe driving and obey the posted speed limits and parking regulations. Students walking off campus must use designated crosswalks.
- Students are expected to be on time to all classes before and after lunch.
- Students that leave for off-campus lunch may not bring food into the building upon their return.
- Students are not permitted to take students who do not have permission to leave campus with them to lunch.
- Students asked or required to stay in for lunch at any time to work with a teacher must comply.
- Students may be assigned lunch detention for disciplinary reasons, which will mean a temporary loss of off-campus lunch privileges.
- Once approved, school ID with the sticker must be presented to security or administration when leaving for lunch.
- Use of illegal substances, such as tobacco, alcohol and drugs, in vehicles on school grounds is prohibited.
- Complaints raised by the community about specific students may result in a loss of off-campus lunch privileges.
- Students approved for off-campus lunch must exit and enter through the doors by the cafeteria.
- In the case of extreme weather conditions, the school administration may limit off campus lunch privileges.
- Students with total absences in excess of 10% are at risk for loss of off campus lunch privileges.

In signing this form the senior student agrees to the above rules and regulations and acknowledge that leaving campus for lunch is a privilege. Failure to abide may result in the temporary or permanent loss of off-campus lunch privileges.
